1. The following public way / alley shall be vacated:



### ORDINANCE NO. 2021-5

## ORDINANCE OF THE TOWN OF WESTPORT ESTABLISHING NEW ONE-WAY STREETS

WHEREAS, it is the responsibility of the Town Council of Westport, Indiana to provide for the public safety, health and welfare of the citizens of the Town of Westport; and

WHEREAS, in carrying out this responsibility, the Town Council of Westport has determined that it is in the best interest of said citizens that two (2) existing "two-way" streets should become "one-way" streets for vehicular traffic purposes;

NOW THEREFORE BE IT ORDAINED by the Town Council of Westport, Indiana that the following streets shall have two-way traffic removed and one-way traffic shall be established as follows:

#### AVENUE

- 1. Johnson Place shall be designated one-way traffic traveling West from Walnut Street to Government Avenue
- 2. Government Avenue shall be designated one-way traffic traveling North from Johnson

  Place to East Main Street

THIS ORDINANCE SHALL BE IN FULL FORCE AND EFFECT FROM AND AFTER ITS PASSAGE.
