

AN ORDINANCE AUTHORIZING THE MARSHALL, TOWN OF WESTPORT, INDIANA, TO APPOINT DEPUTY AND RESERVE DEPUTY MARSHALLS PURSUANT TO INDIANA CODE 36-5-7-6.

WHEREAS, The Board of Trustees, Town of Westport, Indiana, desires to provide adequate police protection for the residents of the Town;

WHEREAS, The Town Marshall and The Board of Trustees believe the Town Marshall requires assistance by two or more deputy marshalls and volunteer reserve deputy marshalls; and

WHEREAS, Indiana Code 36-5-7-6 grants the Town's legislative body, The Board of Trustees, authority to authorize the Town Marshall to appoint deputy marshalls.

NOW, THEREFORE, BE IT ORDAINED, by The Board of Trustees, Town of Westport, State of Indiana:

SECTION 1. DEPUTY MARSHALL(S):

The Board of Trustees hereby authorizes the Marshall of the Town of Westport, Indiana, to appoint / _____ deputy marshall(s), advising The Board prior to appointment of said deputy marshall(s) of the proposed appointees qualifications for the position.

SECTION 2. RESERVE DEPUTY MARSHALLS:

The Board of Trustees hereby authorizes the Marshall of the Town of Westport, Indiana, to appoint _____ reserve deputy marshalls said appointed reserve deputy marshalls to be unpaid volunteers serving at the pleasure of the Marshall, Town of Westport, Indiana.

SECTION 3. BOND:

Prior to any marshall or appointed deputy marshall entering service on behalf of the Town of Westport, Indiana, a commercial bond in the amount of \$8,500.00 shall be in effect for appointees to the above-said positions.

SECTION 4. COMPENSATION:

Appointed deputy marshall(s) shall be compensated at the rate of \$ _____ per hour of service rendered as an employee of the Town of Westport, Indiana, with subsequent compensation increases to be approved by The Board of Trustees adoption of wage/salary ordinances. No compensation shall be paid reserve deputy marshalls.

SECTION 5. CLOTHING ALLOWANCE:

Any appointed deputy marshall shall be entitled to a uniform allowance in the amount of \$ _____.

SECTION 6. TERM OF SERVICE:

Appointed deputy marshall(s) and reserve deputy marshalls shall serve at the pleasure of the Marshall, Town of Westport, Indiana and may be dismissed pursuant to Indiana Code 36-5-7-1 and subsequent sections.

SECTION 7. SEVERABILITY:

All ordinances shall be in full force and effect from and after its passage, approval, recordings, and publications as provided by law.

SECTION 8. EFFECTIVE DATE:

This ordinance shall be in full force and effect from and after its passage, approval, recordings, and publications as provided by law.
