

WESTPORT TRAFFIC ORDINANCE 1987-4

AN ORDINANCE REGULATING TRAFFIC UPON THE PUBLIC STREETS OF THE TOWN OF WESTPORT, INDIANA.

IT IS ORDAINED BY THE TOWN BOARD OF THE TOWN OF WESTPORT AS FOLLOWS:

SECTION 1: Any vehicle parking on any street within the corporate limits of the Town of Westport shall park only on the right hand side of the street as the vehicle faces.

SECTION 2: No person, while operating any motor vehicle within the corporate limits of the Town of Westport, shall have within or on that vehicle, any open container of any type of alcoholic beverage.

SECTION 3: Any person parallel parking any vehicle within the corporate limits of the Town of Westport shall park that vehicle so that the right side tires of that vehicle are no more than twelve (12) inches from the curb.

SECTION 4: No person shall stop, stand, or park a vehicle, whether attended or unattended, except when necessary to avoid conflict with other traffic or to avoid conflict with the directions of a police officer, in any of the following places:

- (A) On the roadway side of any vehicle stopped or parked at the edge or curb of the street.
- (B) On a sidewalk.
- (C) On front of any public or private driveway.
- (D) Within an intersection.
- (E) In any place in which the vehicle restricts the flow of traffic or creates a hazard.

SECTION 5: Any Law Enforcement Officer who finds a vehicle in a location in violation of this ordinance is authorized to require the driver or other person in charge of the vehicle to move it, and if any person so directed shall fail or refuse to move the vehicle or the vehicle is unattended, then the officer is authorized to provide for the removal of the vehicle, at the cost of the owner of that vehicle.

SECTION 6: (Subsection A) The speed limit for any vehicle within the corporate limits of the Town of Westport in and on all streets and alleys shall be thirty (30) miles-per-hour except as provided for in subsections B and C of this section.

(Subsection B) Main Street between its intersection with Dean Street and its intersection with East Street shall have a speed limit of Twenty Miles per-hour for all vehicles.

(Subsection C) State Road 3, upon its entire length within the corporate limits of the Town of Westport shall be fifty (50) miles-per-hour.

SECTION 7: No person shall, at any time, park any vehicle in or on any part of the following streets:

- Kentucky Ave. Kathleen Street, Underwood Drive, Gatewood Drive, North Street, Schott Street, Bennett Street, Sycamore Street, Race Street, South Street Sandi Lane, Paul Street, High School Road, Lincoln Street, Elizabeth Street, Dean Street, Williamson Street, West Street, East Street, Cann Street, Owens Street, Maple Street and Washington Street.

- SECTION 8: No person shall at anytime park any vehicle in or on any part of the following section of Main Street:  
 Between the intersections of State Road 3 and West Streets, between the intersections of East Street and Shady Lane, on the north side of Main Street between the intersections of Poplar and East Streets.
- SECTION 9: No person shall park any vehicle in or on Walnut Street between it's intersections with Bennett and Main Streets, or between it's intersections with Sycamore and Poplar Streets.
- SECTION 10: No person shall park any vehicle in or on Poplar Street at anytime between it's intersections with Schott and Main Streets or between it's intersections with Sycamore and Poplar Streets.
- SECTION 11: No person shall, at any time, park any vehicle in or on Mulberry Street between it's intersections with Lincoln and West Streets, between it's intersections with Poplar and East Streets, or on the South side of Mulberry Street between the intersection of West Street and the intersection of the alley on the East Side of the Fire Department.
- SECTION 12: Parking is allowed on Walnut Street only between it's intersection with Main Street and it's intersection with Sycamore Street and then only on the East side of said street. Parking on the left as the vehicle faces is allowed on the section of Walnut Street mentioned in this section of this ordinance.
- SECTION 13: No person shall at any time park any vehicle so that it in any way blocks or impedes the flow of traffic of any type on any sidewalk within the corporate limits of the Town of Westport.
- SECTION 14: The following streets shall stop at the posted sign at the following street intersections:  
 Main Street shall stop at State Road #3  
 Main Street and Range Street both shall stop at there intersection.  
 Range Street Shall stop at State Road #3  
 Range Street shall stop at Race Street  
 Lincoln Street shall stop at Main Street  
 Elizabeth Street shall stop at Main Street  
 Elizabeth Street shall stop at Mulberry Street  
 Dean Street shall stop at Main Street  
 Dean Street shall stop at Mulberry Street  
 Dean Street shall stop at State Road #3  
 Williamson Street shall stop at Main Street  
 Williamson Street shall stop at Mulberry Street  
 West Street shall stop at Main Street  
 West Street shall stop at Mulberry Street  
 West Street Shall stop at Schott Street  
 Walnut Street shall stop at Mulberry Street  
 Walnut Street shall stop at Main Street  
 Walnut Street shall stop at Sycamore Street  
 Walnut Street shall stop at South Street  
 Poplar Street shall stop at Schott Street  
 Poplar Street shall stop at Main Street  
 East Street shall stop at Schott Street  
 East Street shall stop at Main Street

 Cann Street shall stop at Bennett Street

North bound Kathleen Street shall stop at Underwood Dr.  
Underwood Drive shall stop at Kathleen Street  
Underwood Drive shall stop at State Road #3  
North Street shall stop at Cann Street  
East Bound North Street shall stop at Owens Street  
Schott Street shall stop at Range Street  
Schott Street Shall Stop at Owens Street  
Schott Street shall stop at Maple Street  
West bound Bennett Street shall stop at Owens Street  
Mulberry Street shall stop at Range Street  
Mulberry Street shall stop at Poplar Street  
Mulberry Street shall stop at East Street  
Sycamore Street shall stop at Williamson Street

SECTION: 15: Or any stop sign legal posted, they shall stop in the  
The following streets shall be one way streets in the  
direction indicated and the section indicated within  
the corporate limits of the Town of Westport:  
Poplar Street shall be one way South between Main and  
Sycamore Streets.  
Walnut Street shall be one way South between Main Street  
and Johnson Avenue.

SECTION: 16: Any Person violating any part of this Ordinance shall  
be guilty of a Class C Infraction.
