ORDINANCE 2017-6

AN ORDINANCE CHANGING THE CHARGES FOR DEPOSITS,
TURN ON FEES AND DELINQUENT FEES

NOW THEREFORE BE IT RESOLVED by the Town Council of Westport, Indiana, that the following fee schedule is established for certification for all offices within the Town:

Turn On/Transfer Fee	\$30.00
Water reconnect fee-after hours	\$60.00
Customer Deposits	\$100.00 per utility, not to exceed \$200.00 per customer
Sewer Inspection for home owners	\$20.00

Customer Deposit

An initial deposit shall be charged to the customer before services are initially connected. Customer deposits shall be used first to offset any balance owed by the customer, with the remaining refunded. The former "Water Deposits" shall be converted to "Customer Deposits" and may be used towards any amount owed to the Westport Municipal Utilities. Any unclaimed customer deposits shall become the property of the municipality after 7 years. If the customer has both water and wastewater services, the unclaimed deposit shall be receipted ½ water ½ wastewater.

All ordinances or parts of ordinance in conflict herewith are hereby repealed.


The rates and charges herein established shall be collected from the owners, occupants, and users of the premises within said town from and after the effective date of this ordinance.

The fees and charges in this ordinance will take effect of September 1, 2017.





Customer Deposit



Otherwise the deposit shall be used to offset any charges due and owing by the customer.

All ordinances or parts of ordinance in conflict herewith are hereby repealed.


The rates and charges herein established shall be collected from the owners, occupants, and users of the premises within said town from and after the effective date of this ordinance.

The fees and charges in this ordinance will take effect on September 1, 2017.


