

Ordinance 2019-1

AN ORDINANCE ESTABLISHING SALARIES AND COMPENSATION
FOR EMPLOYEES AND ELECTED OFFICIERS

WHEREAS, IC 36-5-3-2 states the town legislative body shall fix the compensation of its own members, the Town Clerk-Treasurer, Town Marshal and other Town Officers' and Employees.

WHEREAS, the Town Council wishes to establish the salaries shall be effective January 1, 2019.

Therefore, be it ordained by the Town Council that the following salary schedule shall be in full force and effective January 1, 2019.

Effective January 1, 2019 the Town of Westport will convert payroll to a bi-weekly payroll period. The ordinance reflects bi-weekly payroll amounts.


- (1) Fund change may vary based on duties performed.
