AN ORDINANCE TO AMEND ORDINANCE NO. 1987-4 REGULATING TRAFFIC UPON PUBLIC STREETS OF THE TOWN OF WESTPORT, INDIANA

WHEREAS, Indiana Code 36-1-3 et. seq. confers upon units of government within the State of Indiana such powers as necessary or desirable to conduct the affairs of local government;

WHEREAS, Indiana Code 36-4-6-18 authorizes the Town Council of the Town of Westport, Indiana ("Town") to pass such ordinances, orders, resolutions and motions as may be necessary and proper for the governmental unit to fulfill and satisfy the responsibilities and duties of said governmental unit;

WHEREAS, the Town Council previously adopted Ordinance No. 1987-4 regulating traffic upon public streets of the Town of Westport, Indiana; and

WHEREAS, it is the desire of the Town Council to amend Ordinance No. 1987-4 to prohibit the parking of trailers on public roads, to require the use of designated parking along the Town property, and to add roads along which parking is prohibited.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF WESTPORT, INDIANA:

SECTION 1. Ordinance No. 1987-4, Section 7 is hereby amended and shall read as follows:

A. No person shall, at any time, park any vehicle in or on any part of the following streets:

Kentucky Ave., Kathleen Street, Underwood Drive, Gatewood Drive, North Street, Schott Street, Bennett Street, Sycamore Street, Race Street, South Street, Sandi Lane, Paul Street, High School Road, Lincoln Street, Elizabeth Street, Dean Street, Williamson Street, West Street, East Street, Cann Street, Owens Street, Maple Street, Deer Run, Westwood Drive, and Washington Street.

- B. No person shall, at any time, park a trailer in or on any part of a street within the Town of Westport corporate limits. For purposes of applying this section, the term "trailer" shall mean a long platform or box with wheels that is pulled behind a truck or car and used to transport things.
- C. Individuals are prohibited from parking a vehicle on property owned by the Town except in designated parking spaces.

SECTION 2. This ordinance shall be in full force and effect from and after its passage by the Town Council.
